AUTHORISED BUS PARKING PERMIT

Western Sydney Parklands

This permit allows access and parking in Western Sydney Parklands to the following:

Approval to bring a vehicle in excess of 3 tonnes into Parramatta Park and Western Sydney Parklands excluding any vehicle which is over 4 metres in height, over 19 metres in length, over 4 metres in width

As per the parkland regulations no vehicles in excess of 3 tonnes are permitted without obtaining prior approval. Approval for all passenger vehicles in excess of 3 tonnes is provided by obtaining a permit.

CONDITIONS OF USE

Greater Sydney Parklands welcomes groups to Parramatta Park and Western Sydney Parklands and wishes patrons a memorable day. In the interests of safety and enjoyment for all park visitors, access to Parramatta Park and Western Sydney Parklands is granted for your bus to enter the park subject to the following conditions:

- This Permit is only valid if it is clearly displayed and visible on the dashboard of your vehicle at all times with the vehicle registration number, company / organisation details and date completed.
- Access to Parramatta Park and Western Sydney Parklands is granted only during standard gate opening times and this permit is not valid during Event days, vehicle free conditions or in paid or mobility permit parking areas / bays.
- The driver is required to comply with park and road regulations at all times and must abide by traffic and regulatory signs. Fines apply for non-compliance.
- A 30km/h speed limit applies on all roads and a 10km/h speed limit applies in all car parks.
- Coaches and buses can only park in marked bus zones located on the attached maps. Mini buses may use standard parking bays if size permits.
- Parramatta Park operates a 'Restricted Parking Area' scheme. All vehicles must be parked in a marked parking bay. All vehicles must park fully within parking bays as indicated by signs (not outside / adjacent to / across the divider of a bay) and comply with any time restrictions shown on signs.
- Vehicles must NOT at any time drive / stop / load passengers / unload passengers from the cycle or pedestrian lanes.
- Current public liability insurance documentation held by your company/organisation must be available for Park Officers to view on request.
- The driver is responsible for any damage to park gates, bollards, curbing and other park infrastructure caused by their vehicle. All damages must be reported to the Park Office immediately on 9895 7599 for Parramatta Park or 9895 7500 for Western Sydney Parklands.
- This permit is not transferable and is valid only if it is clearly and correctly displayed.
- Directions of Authorised Officers must be complied with.

Please note all visitors to Parramatta Park and Western Sydney Parklands must abide by the Parramatta Park Trust Act & the Parramatta Park Trust Regulations or Western Sydney Parklands Trust Act & the Western Sydney Parklands Trust Regulation.

Greater Sydney Parklands retains the right to withdraw this permit at any time.

Issued per Parramatta Park Trust Regulation or Western Sydney Parklands Trust Regulation.

Failure to comply with the conditions of this permit is an offence pursuant to PPT Regulation or WSPT Regulation. Fines apply.

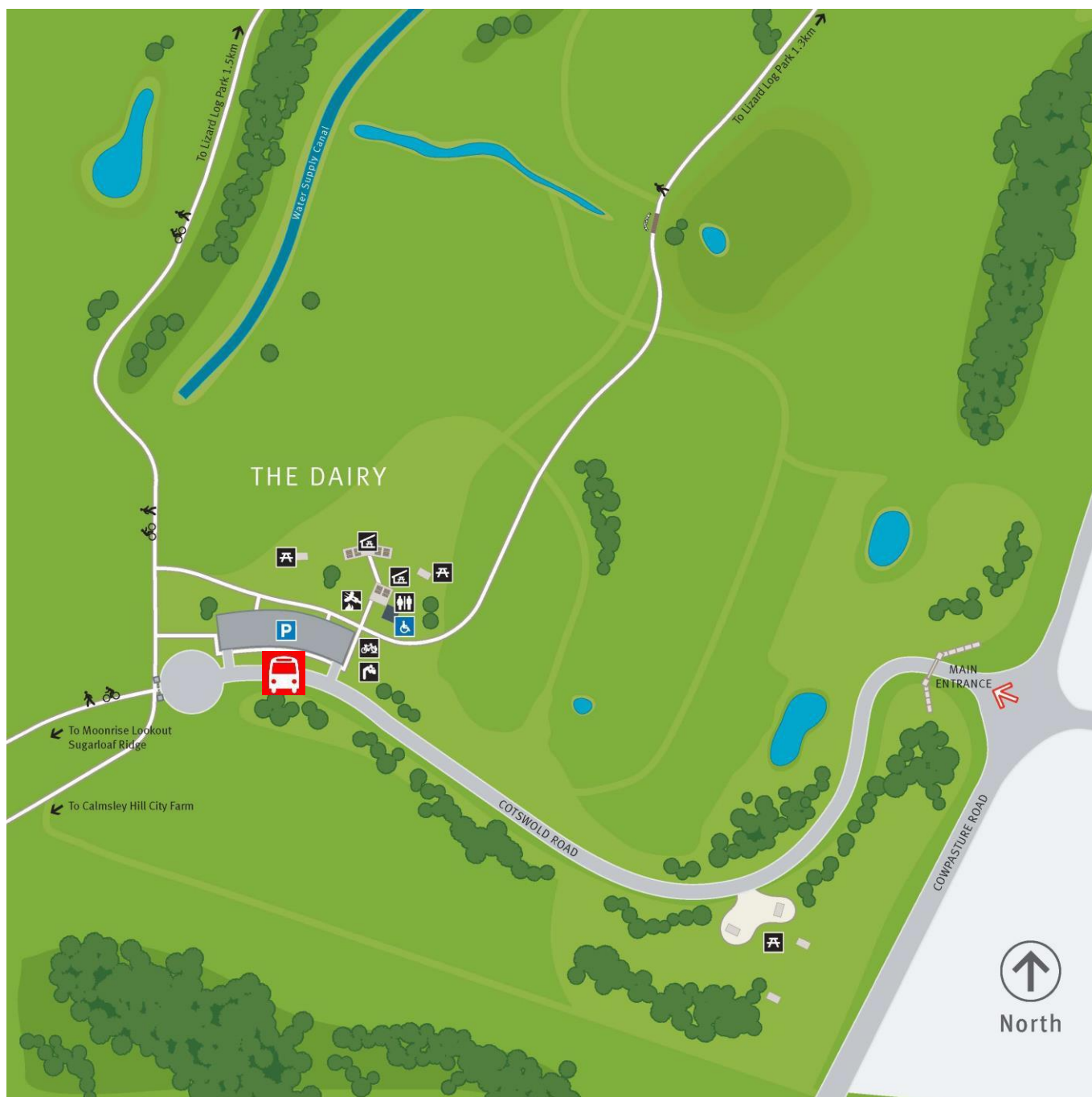
